EBENEZER CHURCH SEWAGE PUMP STATION

Sealed bids (**Bid #14173**) will be received by the Stafford County Purchasing Department for the construction of the **Ebenezer Church Sewage Pump Station**. Bids will be received in the Stafford County Purchasing Office located in the Stafford County Administration Center, 1300 Courthouse Road, Stafford, VA 22554, until 3:00 p.m. prevailing local time, Wednesday, January 4, 2017. Bids received after that time will not be accepted. The bids will then be opened publicly and read aloud.

The project includes the constructing a new Sewage Pump Station (SPS) and the demolition of the existing SPS at the same location. A service line will be constructed between the existing waterline and the SPS. The Project is located about 350 feet northwest of the intersection of Onville Road and Ebenezer Road, on Onville Road. In addition to the SPS and the waterline improvements, the project will include, electrical, mechanical, approximately 0.11 acres of site clearing and grading, chain link fencing, landscaping, and all erosion control, drainage improvements, restoration, and appurtenances.

A Pre-Bid Conference will be held on **Tuesday, December 6, 2016 at 10:00 a.m.**, local time, at the Owner's Aquia Regional Waste Water Treatment Facility, 71 Coal Landing Road, Stafford, VA 22554. Attendance at the Pre-Bid Conference by prospective Bidders is not mandatory, but strongly encouraged.
