## Safety Improvements Route 1 & Telegraph Rd/Woodstock Ln State Project (NFO) 0001-089-721, PE101, RW201, C501 Federal Project STP-511(310)

**Design Public Hearing** The Stafford County Department of Public Works will hold a public hearing on the design of the proposed safety improvements along Jefferson Davis Highway (US-1) from Telegraph Road (SR-637) to Woodstock Lane (SR-639) (“Project”).

The Design Public Hearing will be from **6:30 p.m. to 8:30 p.m. on Wednesday, November 20, 2019, at Widewater Elementary School, 101 Den Rich Road, Stafford, VA 22554**. During the meeting, the public will have a chance to preview the Project information, including the Project schedule, Project design plans, and comment on the Project. Representatives from the Stafford County Department of Public Works, Virginia Department of Transportation, or VDOT, and the County’s engineering consultant will be on hand to answer questions about the Project.

**Environmental Impacts** In compliance with the National Environmental Policy Act (NEPA) and 23 CFR 771, a Programmatic Categorical Exclusion (PCE) was prepared. Pursuant to the National Historic Preservation Act, Section 106, 36 CFR 800, information concerning the potential effects of the Project on properties is also included in the environmental document.
