Sealed Bids (**Bid #1025163**) will be received by the Stafford County Purchasing Office for the **Construction of the Courthouse Area Water Storage Tank and Waterline South Campus Project**. Bids will be received in the Stafford County Purchasing Office located in the Stafford County Administration Center, 1300 Courthouse Road, Stafford, VA 22554, until **3:00 P.M. prevailing local time, Tuesday, October 25, 2016**. Bids received after that time will not be accepted. The bids will then be opened publicly and read aloud.

The Bid Documents consists of one set of plans and specifications. The project plans and specifications for the **Courthouse Area Water Storage Tank and Waterline South Campus** consists of the following work: Installation of a one million gallon water storage tank, approximately 750 linear feet of 16-inch waterline, approximately 300 linear feet of 12-inch waterline, 80 linear feet of steel casing pipe by bore and waterline appurtenances. Also included is the property site work consisting of clearing, grading, storm sewer, stormwater management facilities, an access road, erosion control and landscaping.
